### INTRODUCTION

This Privacy Policy document describes how our club collects, uses, stores and protects the personal information of our members.

#### INFORMATION COLLECTED

Our club collects and stores personal information about our members which is voluntarily completed on our application form, items such as your name, mailing address, email address, and phone number. You also consent to share your photo image in your application.

# **PURPOSE OF DATA COLLECTION**

We collect this personal information in order to manage and operate the club's business such as membership and event registration, and in order to communicate information to you such as meeting announcements and club updates through our newsletters, and other special emails.

# **DATA SHARING**

Our club allows the viewing of your data with the following:

-Assigned Management Team administrators for the purpose of managing the club's operations, including but not limited to managing and correcting invoicing, payments, changes in member's profiles and resolving operational issues. These administrators ensure that no members' contact information is visible to the public and have set Directory privacy settings in the Wild Apricot system to members- only access. -Service provider, Wild Apricot, for problem resolution.

-Service provider, AffiniPay, in partnership with Wild Apricot, to manage secure credit card transactions. Unless you request it to facilitate the transactions, your credit card information is not stored. AffiniPay does not share credit card details with the assigned Management Team administrators.

NOTE: Members shall **NOT** share other members' personal information with non-members.

# DATA PROTECTION AND SECURITY

Your data is protected through our service providers' (Wild Apricot, AffiniPay) encryption protocols, secure servers, and access controls.
